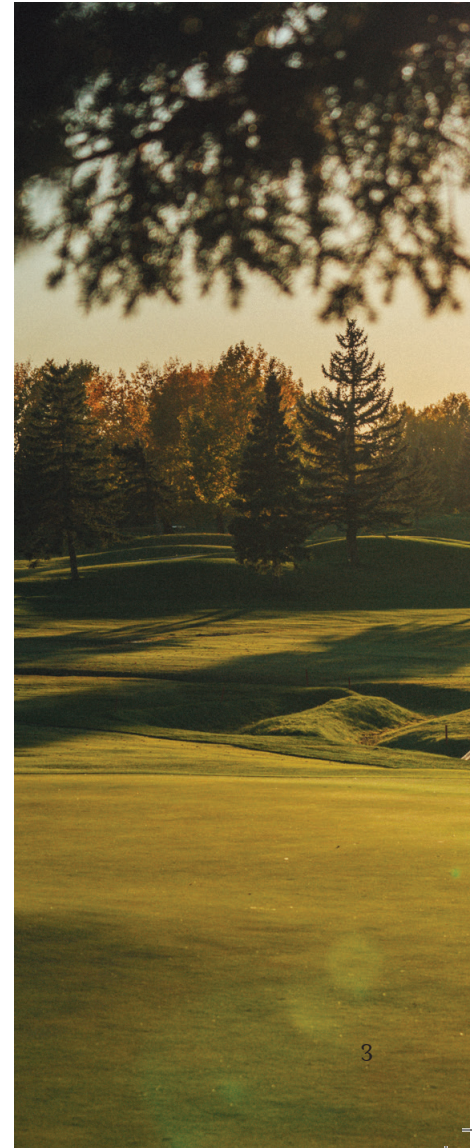

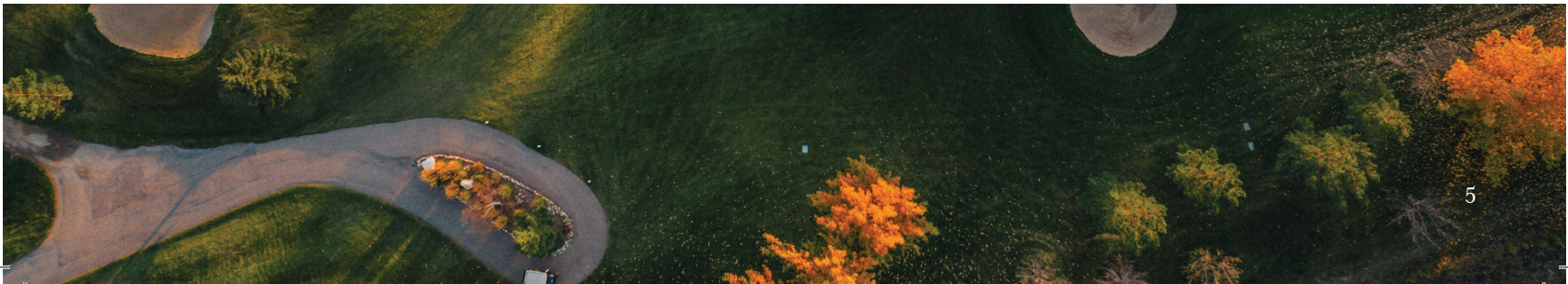

2025 TOURNAMENT BOOKING POLICIES

—

TOURNAMENT OPTIONS FOR PLAY

The Willows offers several formats for tournament play. An 18-hole Shotgun Start accommodates up to 144 players with exclusive access to 18 holes, while a 9-hole Shotgun Start allows up to 72 players with exclusive access to 9 holes. Preferred Shotgun Start days are Tuesdays and Thursdays, with PM starts encouraged; a limited number of Shotgun Starts may also be available on Fridays and weekends. The recommended courses for tournament play are Lakes and Bridges.

The Willows reserves the right to adjust start times, course rotations, or formats if the number of players significantly differs from the original booking. Additionally, we may assign an alternate banquet room suited to your event's needs and fill open tee times with other golfers as necessary. In Shotgun Starts, 18-hole tournaments will play 18 holes sequentially, and 9-hole tournaments will play 9 holes sequentially.

All non-shotgun bookings are considered Tee Time events, beginning as traditional rounds from the first tee at 9- or 10-minute intervals.

FINAL PAYMENT

The Tournament host will be invoiced following the event for the balance remaining, less deposits. Payment is due within seven (7) days upon receipt of the invoice and payment may be made by cheque or debit card. 1.5% Interest will be charged per month on all invoices not paid within 30 days.

FOOD & BEVERAGE SERVICE

The Willows Club is the exclusive provider of all food and beverages, including liquor, beer, and wine, ensuring compliance with Saskatchewan Liquor and Gaming Authority regulations. Bringing outside alcohol onto the course is illegal, and any unauthorized products will be confiscated, with potential removal from the golf course for those involved. To protect our liquor license, we maintain a zero-tolerance policy on this issue. The Willows Club also reserves the right to discontinue alcohol service to any guest who appears intoxicated, prioritizing a safe and enjoyable environment for all.

PACE OF PLAY

To ensure all guests have an enjoyable experience, we ask that shotgun tournament groups complete their rounds within five (5) hours, while tee time tournaments should aim to finish within four (4) hours and fifteen (15) minutes. Our on-course Ambassadors and staff have the authority to monitor and maintain this pace. Tournament formats can be adjusted to support pace of play, such as “tee it forward” or “par golf”—please discuss these options with our tournament coordinator if interested. Slow players may be asked to play from forward tees or advance to maintain the expected pace.

DRESS CODE & ETIQUETTE

At The Willows, we are committed to upholding the integrity and enjoyment of golf and kindly ask all participants to follow essential etiquette and dress guidelines to ensure a memorable experience for everyone. Our Player Ambassadors will be on the course to help monitor pace of play and answer any etiquette questions. In terms of general etiquette, we ask that all golfers respect the greens by repairing their ball marks and at least one other, care for the fairways by replacing divots, and rake bunkers after use. Only soft spike shoes are allowed, as metal spikes are prohibited. To maintain a comfortable and respectful environment, our dress code requests that golfers wear collared or sleeveless golf shirts, along with appropriate footwear such as golf or running shoes or golf sandals. Torn or tattered jeans, gym wear (like spandex or sweats), muscle shirts, tank tops, swim wear, and flip-flop sandals are not permitted. Shirts and shoes are required at all times.

2025 TOURNAMENT CONTRACT

DEPOSIT & PAYMENT INFORMATION

Tournament date and times will only be confirmed by receipt of the initial \$1000 deposit for Shotgun events or \$500 deposit for Tee Time events. Such deposit will be applied to your final bill. The second deposit of \$2000 will be due 30 days prior to tournament start date (shotgun only). Remaining estimated golf balance will be due prior to the tournament start date. The Tournament host will be invoiced following the event for the balance remaining. Payment is due within 7 days upon receipt of the invoice. Final payment may be made by cheque or debit card. 1.5% Interest will be charged per month on all invoices not paid within 30 days.

GUARANTEE NUMBER OF GOLFERS AND PLAYER DRAW

The estimated number of golfers must be conveyed on the original Tournament Application. You must guarantee the number of golfers playing in your event **ten (10) days** prior to your event. If these numbers are not conveyed to our Tournament Coordinator, the number of golfers you submitted on your original tournament application becomes your guaranteed number. Your final invoice will reflect your guaranteed number of golfers attending, or the number of golfers you submit on your player draw, whichever is greater. Your player list, or draw, must be emailed to The Willows Tournament Coordinator a minimum of **48 hours** in advance of the start of your event. Changes to the tournament list cannot be guaranteed after the stated deadline.

PLEASE INITIAL HERE TO ACKNOWLEDGE THE ABOVE _____

MINIMUM REQUIREMENTS

If you have booked a shotgun tournament and your numbers are less than expected and you wish to change the format to your event to a tee time tournament, you must notify The Willows Tournament Coordinator **ten (10) days** prior to your event date. Failure to do so will result in the shotgun rate for the day being charged to the final invoice. See Tournament Application page for pricing and number requirements for each tournament type.

POWERCART RENTAL AGREEMENT

Power carts are required for all tournament play. “As the sponsoring organization of the tournament, we hereby (1) agree to hold harmless, indemnify or defend The Willows Club and it’s owners and agents from against any injuries or damages of any kind whatsoever to any person or entity out of or in any way resulting from the negligent or reckless use or operation of a power cart; (2) agree to reimburse The Willows Golf and Country Club for any such injuries or damage done to any power cart or property; (3) agree to allow any person of legal driving status to operate a power cart.” Participants abusing the equipment or disobeying the requests of the staff may be asked to withdraw themselves from your event and/or the cart(s) may be confiscated. If additional carts are required for rental, the cost will be \$50.00/cart.

CANCELLATION POLICY & WEATHER

Tournaments canceled more than 60 days before the event will receive a full refund of any deposit. Cancellations made 31 to 60 days prior to the event will result in a 50% deposit refund, while cancellations within 30 days of the event will forfeit the deposit entirely. In the event of a course closure due to inclement weather, beverage service will proceed as scheduled unless The Willows Golf Course Superintendent determines the course to be unplayable. If the course closure does result in event cancellation, tournament organizers will receive passes equivalent to 144 rounds with power carts for an 18-hole event (or 72 rounds with power carts for a 9-hole event). The banquet will still proceed, with a start time mutually agreed upon by the tournament organizer and coordinator.

DAMAGES

The Tournament Host is responsible for the actions of its participants. The Willows Club shall not be responsible for any loss or injury suffered or incurred by any tournament participant unless such injury is caused by the negligent or wrongful act of The Willows or its employees. Participants are responsible for any damages to the golf course, the clubhouse, any adjacent or fixed property and or any lost or negligent damage to rental golf equipment and to the power golf carts. In the event that a participant has damaged or lost any of the above items and neglects to inform the staff of The Willows or the booking host, the host will be responsible for any/all costs associated with the damage or loss and will be invoiced on the final bill.

TOURNAMENT HOST RESPONSIBILITIES DURING FUNCTION

The Tournament Host or the designated day of on-site contact for your event shall be responsible for keeping order during all activities, both on and off the golf course and during the banquet function. This includes and is not limited to ensuring that entertainment is appropriate, that your function is not unlawful or

disruptive to other Willows guests, including appropriate volume controls of guests and entertainment, and that your guests are contained within the banquet space booked for your event. Physical or verbal abuse of The Willows employees or property will not be tolerated. Offenders will be removed from the premises and security or police will be notified. The Willows reserves the right to discontinue alcohol service to any guest who appears to be intoxicated or is acting inappropriately.

ADDITIONAL FOOD AND BEVERAGE CONSIDERATIONS

Guaranteed Numbers And Meal Selection

Menu selections and any additional enhancements must be provided to The Willows Events staff no later than 30 days before your event. Ongoing communication between the Events staff and the Tournament Host will help ensure all details are covered. The final guaranteed number of dinner attendees must be confirmed five (5) business days before the event. If this number is not provided, the originally booked number or actual attendance will be used for invoicing. An 18% gratuity will be added to the final Food and Beverage invoice.

Beverage Service

The Willows Club provides beverage service from our lounge, banquet areas, Watering Hole, and on-course beverage carts. Per SLGA regulations, outside alcohol is not permitted on the premises. We are committed to responsible beverage service and adhere to all SLGA regulations, including those concerning service to minors and visibly intoxicated guests.

Last Call: For events inside The Willows Clubhouse, last call is at 12:30 AM, with bar service ending at 1:00 AM. For events at The Red Barn, last call is at 9:30 PM, and all functions conclude by 10:00 PM.

Bartender Fee: Bars that do not reach a minimum of \$300 in sales (excluding tax and gratuity) will incur a bartender fee of \$100.

Food and Beverage Policies

The Willows Club is the exclusive provider of all food and beverages (including liquor, beer, and wine). In line with Saskatoon Health Region regulations, all food and beverages must be handled, prepared, and served by our staff. We cannot permit any outside prepared food on the premises except in cases of severe allergies, which should be discussed with the Events Sales Coordinator at least five (5) business days before the event.

Food served at banquets will be available for up to 2 hours inside The Willows Clubhouse and 1.5 hours in The Red Barn. Following health and safety guidelines, leftover food may not be removed from the premises.

Donated Food and Beverage Products

Requests regarding donated food or beverage items must be submitted to our Events Coordinator at least 30 days in advance. Any activities on the golf course involving donated food or beverages will be considered on a case-by-case basis, in compliance with Saskatchewan Health & Safety and SLGA regulations.

Please note that food and beverage pricing is subject to change without notice.

The Willows Club does not allow outside food or beverage. If you are wanting to supply Food or Beverage on course during your tournament, it must be purchased through the Club. Any alcoholic beverages purchased from the Club with the intention of being handed out during the tournament, will need to be done so by a Willows staff member. There will be a \$100 service fee per staff member required.

SPONSORSHIP

The Tournament Host will be invoiced for the full event amount, including any sponsored items and associated fees. The Willows is not responsible for collecting payments from sponsors.
